# STUDENT AGREEMENT Diploma in Outdoor Adventure Himalayan School of Outdoor Recreation

An undertaking of Himalayan Education Partnership affiliated House of Rajkarnicar

# 1. Student Conduct Policy

In order to maintain an environment conducive to learning, students must meet program standards of good conduct and behavior while during the diploma academic program. This means courteous attention, good manners, and careful handling of the gear and equipment being used for the training.

### a. Attendance

Students are expected to be regular and punctual in his/her classes. Leave applications duly signed by parents/guardians must be approved by the Chief Administrative Officer. Student must record 90% attendance in order to qualify for graduation.

#### b. Conduct

Students are required to maintain a high level of discipline and behavior. Disciplinary action will be taken to student showing aggressive behavior towards school teachers, staffs or colleagues. In case of severe cases, they may be terminated from the program. Students are required to switch off their cell phones in class and during outdoor sessions.

# c. Prohibited Consumption

Any students found consuming alcohol, using drugs or smoking cigarettes inside the school premises will be immediately terminated from the program.

## d. Damage to School Property

Students are liable to pay for the school property broken or damaged by them.

## 2. Adventure Gear

I am responsible for the following personal possession of following gear required for practical training of courses.

- a. Trekking boots with high traction rubber soles.
- b. Waterproof poly-filled or down jacket with hood
- c. Water-proof sleeping bag with temperature rating of -5 to -12 degree Celsius
- d. Water-proof 50 liters plus rucksack

# 3. Financial Responsibility

**Tuition and Training Fee** - I understand and accept that the full fee of Rs. 300,000 must be paid 50 % upon registration and the remaining in installments preceding every semester on a timely manner. The Tuition and Training Fee does not include insurance, food expense, hostel accommodation in Goa and CTEVT test fees. Likewise, the insurance, food and accommodation if any must be paid 30 days before the departure date.

**Practical Training Field Trips** - I am responsible for my personal gear such as trekking boots, jacket, sleeping bag and rucksack for any practical training field trips (transportation, adventure sports equipment and tented accommodation are provided by HSOR). In addition, I am responsible for insurance premium for trip accident and evacuation, food expense and accommodation in the case of Goa (hostel accommodation) to be charged by HSOR on cost basis. An estimate cost may be requested from Admissions office.

**CTEVT** - I am responsible for the test fees charged by CTEVT for the Trekking Guide Course and Riverrafting Guide Course and payable to HSOR.

# 4. Media Release Rights

I hereby assign all rights and release from liability Himalayan Education Partnership Pvt. Ltd. and its entity, Himalayan School of Outdoor Recreation for the recording, print production, exhibition, video/audio production, broadcasting, cable-casting, internet access, web-casting, and distribution of my child's visual image and/or voice for promotional /not profit use. Students may be photographed or filmed during their class-room study practical training.

#### 5. Claims

I may only claim on the commitments or pledges made in writing by Himalayan School of Outdoor Recreation.

## 6. Assumption of Risks

I fully understand and accept that the academic program of Diploma in Outdoor Adventure comes with certain inherit risks that cannot be eliminated regardless of the care of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attack, and concussions to 3) catastrophic injuries such disability or death.

# 7. Medical Emergency

In the event of any emergency illness or injury, I or my family cannot be contacted and immediate tests and treatments are required, I give full authority to the district staff to obtain such medical tests and treatment and/or surgery from a licensed physician/surgeon, paramedic or hospital as deemed necessary for the welfare of my child. The cost of tests and treatment shall be paid by me and my family or insurance policy.

### 8. Indemnification and Hold Harmless

I and my family agree to INDEMNIFY AND HOLD HIMALAYAN EDUCATION PARTNERSHIP PVT. LTD. AND ITS ENTITY, HIMALAYAN SCHOOL OF OUTDOOR RECREATION HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the academic program and to reimburse them for any such expenses incurred.

## 9. Parental Consent and Liability Release Waiver Agreement

I grant approval for my child to attend Himalayan School of Outdoor Recreation for 2 years academic program of Diploma in Outdoor Adventure. I, for myself, my spouse, my children, my heirs, personal representatives or assigns, hereby release, waive, discharge, and covenant not to hold Himalayan Education Partnership Pvt.
